BEAUCLERK, Lady Diana, née Spencer

London 24.III.1735 – Twickenham 1.VIII.1808
Daughter of the 3rd Duke of Marlborough (born in 1735, not 1734 as is often reported), Lady Diana Spencer married Viscount Bolingbroke in 1757 and was appointed lady-in-waiting to Queen Charlotte in 1761. After her divorce in 1768, she married Topham Beauclerk. She was recorded in Bath in 1776–77 (residing at 12 South Parade and 4 Russel Street). She specialised in subject pictures of children, and also made designs for the Wedgwood factory.

An amateur artist with imperfect draughtsmanship, her work as an illustrator (of Dryden and Walpole) was nevertheless admired by Reynolds and Walpole (who said she “painted well in crayons”), and engraved by Bartolozzi. She drew using a range of techniques, and a number of recorded works described as in pastel include other media. She also “drew caricatures admirably and cut them out in paper like Monsr. Hubert of Geneva” (Walpole).

She was cited (as the “Countess of Bolingbrooke” [sic] as a satisfied client in an advertisement for Jurine’s method of fixing crayons in the *Gazetteer & new daily advertiser*, 28.I.1765.

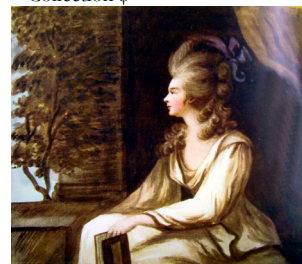

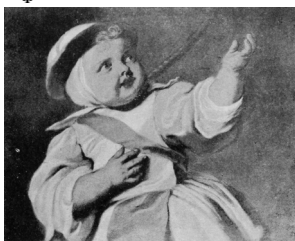
