BERGLER, Joseph, d. J.

Salzburg 11.V.1753 – Prague 25.VI.1829

The son of an Austrian sculptor and painter, Joseph or Josef Bergler the younger travelled to Italy 1776–86 with support from Graf von Firmian, Fürstbischof von Passau. He studied under Martin Knoller in Milan and Anton von Maron in Rome. He returned to Passau in 1786.

Around 1795, presumably in Coburg, Bergler made series of pastels of members of the family of Franz Anton Herzog von Sachsen-Coburg-Saalfeld which are now in Coburg (attributed to Schröder in Coburg 1997), with some also in the Palais royal, Bruxelles, and in the English royal collection. They were copied in oil by Herbert Luther Smith (1809–1869) for Queen Victoria in 1844 (Osborne House, RCIN 406209–218), and in enamel by Duchesne by 1842.

In 1800 Bergler moved to Prague where he helped establish the Akademie für bildende Kunst of which he was first director; he was also Custos der Bildergalerie des Grafen Czernin. He produced religious, landscape and figure paintings and was a draughtsman and engraver. Some of his drawings are signed JB.

Some pastel copies of his religious paintings were exhibited at the Prague Academy in 1822 by Johann Pechtel, presumably his pupil.
