#### BLYTH, Benjamin

Salem, Massachusetts 1746 – Zanesville, Ohio 1811

Benjamin Blyth (Bly, Blithe or Blythe) belonged to a family established in Salem in the seventeenth century; his grandfather was a shipwright and tallow-chandler, and his parents were Samuel, a sailmaker, and Abigail Massey. Benjamin is said to have been named after his uncle Benjamin (1711-) who was dead by 1744. Among six brothers, Samuel II Blyth (q.v.), was an heraldic and commercial painter, while William (1750- ) was also recorded as a painter without further evidence. Benjamin began his career as a pastel portraitist in the 1760s. He also worked in oils (not very well) and miniature (rarely), and made engravings in collaboration with John Coles of Boston. Biographical details remain uncertain, but modern sources concur that Benjamin was born in 1746, two years after Samuel. However the entry recording the admission of the "artist" "Benjamin Blyth" to the Essex lodge of freemasons in 1781 gives his date of birth as 1740 and his parents as Benjamin (the uncle mentioned above) and his wife, Mary Legary of Lynn (who remarried in 1744 as a widow). It cannot be completely excluded that the pastellist had a homonymous cousin.

Nothing is known as to how Benjamin adopted the medium of pastel in the 1760s, although it is natural to speculate some connection with Copley, who had written to Liotard in 1762. There is a chronological issue with the dates of the famous Adams pendants, which are supposed to date to the early 1760s. Blyth's first and only signed work is the portrait of Cabot, 1767, and the next document is his advertisement in the Salem gazette of 10–17.V.1769, announcing that he—

Begs Leave to inform the Public, that he has opened a Room for the Performance of Limning in Crayons at the House occupied by his Father in the great Street leading towards Marblehead, where Specimens of his Performance may be seen. All Persons who please to favour him with their Employ, may depend upon having good Likenesses and being immediately waited on, by applying to their Humble Servant, Benjamin Blyth.

Until 1782, he remained in Salem where, according to the Rev. William Bentley's diary (25.x.1809), the "wretched dauber" gained "much employment from the money of privateer men". The bill for the pastel of General Thomas is probably indicative of his charges (at least for his larger pastels, in 1777): 4 gns for the crayon picture, £1 16s. for the frame and glass, and 3s. for a box.

Legal documents recently located by Norton (2014) indicate that he was absent from Salem for extended periods between 1774 and 1780. In 1769 he married Mehitable Cook in Salem; by 1782 their three sons were aged 1, 9 and 11. Blyth left Salem in 1782 (although there is no evidence that his family went with him), probably as a result of a law suit following a disastrous adventure in privateering (a ship in which Blyth had a major interest had to be repaired at great expense, and Blyth was unable to meet the £1181 15s. 4d. awarded against him by the court).

He moved to Virginia, where, in Norfolk County in 1785, he married a widow, Mary Dougle (the fate of his first wife is not known), and was recorded as a member of the local masonic lodge. The following year he seems to have settled in Richmond, advertising in the *Virginia gazette* (19.VII.1786, repeated several times), in substantially the same terms as the Salem advertisement, adding oil and miniature to crayons, and seeking also an apprentice. By 1811, when he died in Ohio, he had given up art; a third wife is recorded.

In the past a great many American pastels were routinely attributed to Copley, and a number of Blyths are among these. A few dozen pastels are now attributed to Benjamin, but few are actually signed, and the œuvre is by no means securely identified. The suggestion that those made in Salem after 1782 must be by Samuel is plausible, but uncertain; there seem to be several hands at work in some of the earlier pastels. Technique, materials and level vary; condition and excessive restoration also confuse attributions. One feature that recurs is the presence of the sitter's hand across the chest, raised unnaturally high so that it can be included in what are otherwise standard bust-length portraits; but even this may just be a local practice (perhaps influenced by pricing conventions).
