### DOYLE, William Massey Strode

Boston 1769–3.v.1828

The son of a British army officer based in Boston, Doyle was listed in the Boston city directories between 1796 and 1827, first as a wallpaper manufacturer. By 1803 he had become a “painter of manuscripts and portraits”. In 1805 he joined the Columbian Museum as “miniature painter”. The museum had been founded by Daniel Bowen in Boston in 1795, and displayed waxworks, natural history specimens and curiosities as well as paintings by Robert Edge Pine and others. It was destroyed by fire twice but reopened. Bowen’s financial problems led to Doyle becoming owner of the institution, which continued until 1825 when the collections were sold to the New England Museum. Numerous silhouettes and miniatures by Doyle are known, as well as some large pastels of mediocre achievement and 19<sup>th</sup> century feel which are not included here. There are confusions with homonyms, among them Doyle’s daughter, Margaret Byron Doyle, later Mrs John Chorley, who made some pastels in the early nineteenth century.

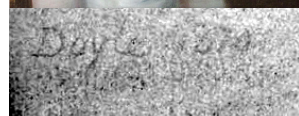
