DUNLAP, William

New Jersey 19.II.1766 – New York 28.IX.1839 Dunlap was only 17 when his portrait of Washington was drawn from life at Berrien Mansion, Washington's headquarters at Rocky Hill, New Jersey, where the artist was a guest of John Van Horn (or Horne), to whom the pastel was presented. He then (1783) went to England to train with Benjamin West, admitted to the Royal Academy schools in 1784, returning to the USA in 1787 when he devoted himself to the theatre as playwright and manager of the Park Theatre in New York. After its bankruptcy he returned to portraiture, working in miniature. Dunlap published a history of drawing in the USA in 1834.
