Also Jelgerhuys, or Jelgerhuijs; the son of a jeweller who moved to Amsterdam in 1735 but returned to Leeuwarden after his father's death in 1745. He remained active as a painter, draughtsman and engraver for many years, but he also started a dye-factory for cotton and linen in Leeuwarden which secured him a gold medal from the Bataafsch genootschap although the venture was not a commercial success. His engraved self-portrait describes him as a "Craion Pict", and shows him wearing unusual double-framed spectacles (a forerunner of bifocals), apparently of his own invention. His interest in the mathematics of perspective led him to publish a treatise on the subject in 1769. He also taught drawing, according to an advertisement in the *Leeuwarder Courant* (9.XII.1769). Together with his wife and three children, he left Leeuwarden in 1772; he is successively recorded in Amsterdam (1772), Rotterdam (1777), Delft, Kampen and finally Amsterdam. His son Johannes Rienksz. Jelgerhuis (Leeuwarden 1770 – Amsterdam 1836) was known as a painter and engraver, but left at least one nineteenth-century pastel.

He is reputed to have produced 7763 works in various media (the numbers found on many are presumably sequential, and had reached 4153 in 1794); of these only about 100 survive today. A large number of mainly nineteenth century works are listed in the rKD files, only some of which are catalogued here. There is some confusion with works by his son Johannes (*q.v.*).

Jelgerhuis worked fast, completing two portraits in a single day. The pastels are rather primitive in execution and of limited aesthetic interest, although the use of pastel for group portraiture is unusual. Some of these works have up to eight figures, often seated round a table. Compositions are repetitive: arms rest on tabletops, often covered with blue cloth; the same carpet reappears; the ladies' feet rest on footwarmers. One interior shows a Perronneau pastel.

An anecdotal obituary appeared in the *Algemeene Konst- en Letterbode voor het jaar 1806* (Haarlem, pp. 355–59), shortly after his death.

A manuscript treatise on the manufacture and use of pastels, *Onderrigting in het maaken van pastel, crayon en de manier, hoe daar meede te werken en wat daartoe behoort* (Rijksmuseum Research Library, MS 310K, donated by Adolph Staring), was written by the artist in 1794 for his son. He describes the choice and preparation of the support (paper or parchment: the latter "if you want to make something delicate and beautiful"), indicating that he pasted the paper onto veneer panels rather than onto canvas. He provides recipes for all colours, using standard artists' pigments, mixed with egg white and pipe clay; these he arranged by their use in different parts of the anatomy of a portrait. The artist confesses to his son that he only earned 15–20 stuiver, or a guilder, for each portrait. A method for fixing the results is also described: this involves floating the sheet on liquid, and

probably accounts for the oxidised tidemarks found on most of Jelgerhuis's surviving pastels.

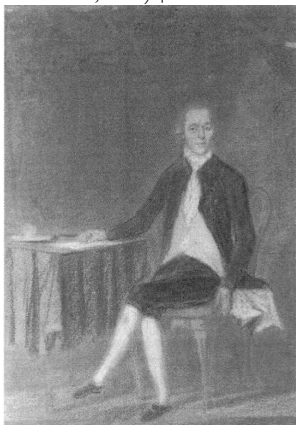

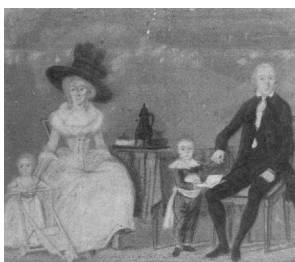

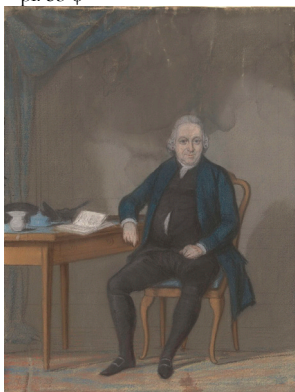

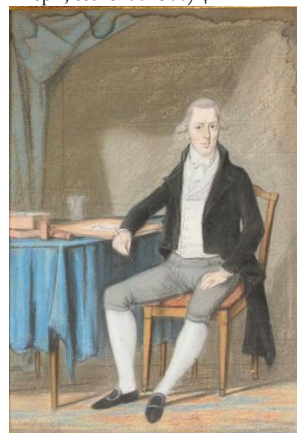
