LA CROIX, Isaac de

Amsterdam 27.V.1752–1.VI.1840

Portrait draughtsman; son and pupil of Pieter Frederik de La Croix (*q.v.*), whose style he closely followed. A number of works dated after Pieter Frederik's death may well be by him. He also made miniatures. Hitherto identified from his signature only as "J. de la Croix", it is now (2024) clear that this artist was the son Isaac baptised in Amsterdam (by his uncle) 31.V.1752. In 1793 he married Martha Boudaud in Utrecht; she died in Nieuw-Loosdrecht in 1815. He died 1.VI.1840, aged 88 (as advertised in the *Nieuwe Amsterdamsche Courant: Algemeen Handelsblad*, 6.VI.1840, published here in 2024), 174 years after the birth of his grandfather. He was in Rotterdam when he placed a notice of his mother's death in the *Rotterdamse Courant*, 21.VIII.1794. He is unlikely to have pursued an artistic career professionally other press mentions suggest he was involved with trade to Paramaribo, Suriname.
