## LAWRANSON, William

London 1742-c.1783

Son of the portrait painter Thomas Lawranson (q.v., also Lawrenson, Laurenson), he won prizes at the Society of Arts in 1760 and 1761. He exhibited pastels at the Society of Artists from 1765 to 1770 and at the Royal Academy (where he was admitted as a student on 14.II.1769) from 1774. His address is usually given as Great Russell Street, presumably the same as his father's. He also worked in oil and made engravings, and a number of his portraits were engraved by Jones, Pether, Dixon and Dunkarton. A print engraved surreptitiously by Dunkarton after Lawranson elicited the objections of the sitter, the actress Miss Catley, who sought half the profit from its sale for her permission (notices in Morning chronicle, 2.IV.1777). His subjects are often drawn from the world of art or the theatre, and his clientèle overlapped with that of Hamilton (he may have worked in Ireland in the mid 1780s).

"William Lawranson, Great Russell Street, Limner" appears in the Bank of England archives as the holder of 3% consols: he purchased £100 nominal of the stock in 1764, but seems to have disposed of it in three amounts between 1766 and 1767.

Lawranson (or his father?) was evidently considered to be among "the most eminent" pastellists when he was consulted (along with Liotard, Russell, Milbourn and Bartolozzi) by the Society of Arts in 1772 in connection with Charles Pache's pastels (minutes, 4.XII.1772, repr. in TREATISES).
