# Neil Jeffares, Dictionary of pastellists before 1800

### **ROMNEY**, Peter

Dalton-in-Furness 1.VI.1743 - Stockport .V.1777 Brother of George Romney (q.v.), with whom he studied at Kendal betweeen 1759 and 1762; he then worked in Manchester and Liverpool. In a letter quoted in his nephew's memoir, he writes around this period "I have finished fifteen pictures...all in crayons, which is the manner I design wholly to pursue, as it is not only more expeditious, and more pleasing in effect than oil colours; but different from my brother's, and greatly in fashion." In 1774 he was in Ipswich where he seems to have taken to drink. He was imprisoned for debt in 1774 at the instigation of his frame-makers, Allwood & Murray; his release was effected by the generosity of his patrons, chiefly of Professor Lambert whom he then accompanied to Cambridge. Here he made portraits in black and white chalk at 3 gns each, according to a letter to his brother of 10.VI.1774, which also includes the names of some of his sitters (without specifying the medium). Some further pastels were made in Stockport in 1776.

The few works known from old photographs are free in technique and forward-looking, but seem to be more gouaches than pastels. Many of these were catalogued by R. R. M. Sée, and the attributions, identifications and descriptions of media should be treated with caution.
