#### RUSSELL, William

London bpt 26.XI.1784 – Shepperton 14.IX.1870 Third son of John Russell (*q.v.*). His date of birth is given differently: Williamson has 1782 and 1780, while Webb 1910 and the Oxford DNB give 26.XI.1784, when John and Hannah's son William was christened at St Mary's, Marylebone (as were five other children in the records between 1778 and 1785). He executed pastels and exhibited at the Royal Academy and at the British Institution between 1805 and 1809 when his output fell off and he turned to the church. In a letter to his mother of 24.III.1809, discussing the prospects for continuing his father's business, he wrote as follows—

With respect to the Enamels I believe they will prove of very little value. It is true they cost a good deal. You speak of interst in the busines to be given up — one thing seems to be requisite — the name of Russell & this I have found is no substitute for capacity. The Crayon making will be only an advantage to a professed crayon maker. If there was a tolerable good crayon painter or if the art was in any degree in fashion I should alter my tone.

At his ordination in 1814 (not 1809), he vowed to abandon art. He was rector of Shepperton for 53 years. The known works are all nineteenth century; they include a portrait of Judge Bayley, commissioned for the Law Courts, which was initially rejected as the judges thought pastel would not be durable; an oil repetition was supplied. In 1851 William Russell's daughter Laetitia Neale Russell married John Walter Lea, the grandson of a nonconformist portrayed by John Russell; and a group of Russell portraits belonged to members of the Lea family in 1894 including one of William's son John Fenn (1828-1882) as a child: if correctly identified the work cannot be by John Russell, but may be by William. The Russell album assembled by Francis H. Webb, William Russell's great nephew, contains a section on his work.
