SKIRVING, Archibald

Haddington 1749 – Inveresk 19.v.1819

Portraitist in miniature, pastel and oil. The son of a farmer, Skirving was probably taught in the early 1770s at the Trustee's Academy in Edinburgh, an institution founded by the French artist William Delacour (*q.v.*) and continued by his compatriot Charles Pavillon. Skirving continued to work as a customs officer, practising his art by night, until in 1777 he decided to move to London (armed with letters of introduction, among them one to John Hamilton Mortimer). Skirving would have found little guidance in pastel in Edinburgh before this trip; the two early pastels attributed to him are very different in approach to his later work. In London he exhibited three miniatures at the Royal Academy in 1778 (from Mrs Milward's, Little Brook Street), but virtually nothing else is known about this period of his career. He returned to Edinburgh in 1784; a letter from his brother Robert in Bengal confirms that Archibald had determined to settle in Edinburgh, and had abandoned miniature painting for crayons "as it will not be so bad for your eyes nor confine your chest so much". The pastel of David Hume's niece, cited in a letter of 1785 (according to Skinner 1970, based on papers belonging to Skirving's descendant Mrs Hoskins since lost), indicates however that he had already become remarkably proficient, and invites speculation as to whether earlier pastels may be languishing under false attributions.

Skirving's continued lack of success in Edinburgh led him to contemplate abandoning art. However, with help from Lord Elcho, in 1786 he travelled to Rome, where he stayed for some eight years (he is recorded among the British artists with lodgings in the Palazzo Babuino near the Piazza di Spagna). Initially he copied old masters and made miniatures, but he may well have met Hugh Douglas Hamilton there, and he certainly recognised the potential for making portraits of Scottish visitors to the city. A letter to his brother, of 18.III.1790, lists a number of these. From the same period come the striking self-portrait and the portrait of Gavin Hamilton, perhaps his two masterpieces, both of which illustrate his fastidious technique. He was noted by a number of travellers at the time. Sir William Forbes (whom Skirving introduced to Tischbein) observed that Skirving "paints small portraits with considerable merit but he takes so much time and bestows so much labour finishing his pieces that he can never do much, indeed can scarcely live by his art."

On his return in 1794, his ship was captured and he was imprisoned for nine months at Brest, accused of spying. This episode provoked a serious eye complaint, and also seems to have confirmed his introverted personality (subsequently he is said to have issued an ultimatum to Lady Charlotte Campbell requiring her to stop her distracted behaviour during sittings; the pastel was accordingly never finished). Such a trait, reinforced by stories of his frugality and caustic wit which remind us of La Tour, was less acceptable in Edinburgh than in Paris, and his social isolation probably

accounts for his failure to achieve the fame deserved by his unusual talent. Neither did Skirving's equally bold treatment of his sitters in the portraits themselves meet with critical acclaim: Patrick Gibson (1816) attacked his "bad taste" in carefully and accurately representing "the personal deformities of his subjects" without regard to their feelings. Although it was during this period after his return from Rome that most of his work was done (from an unfashionably small apartment on Leith Terrace), the output was small (Stephen Lloyd estimates that the 25 surviving works may be half the original oeuvre) and his clientèle seems largely confined to family and acquaintances. Exceptionally high prices of up to 100 gns, linked to the need for up to 50 sittings, no doubt account for this. He appeared at the Royal Academy only once after the 1778 submissions: in 1799 his pastel of John Clerk was shown, presumably before final touches (it is dated 1800). After a brief trip to London in 1816, Skirving retired to his sister's farm.

While Raeburn and Danloux may also have influenced the later work, all Skirving's mature pastels display a very personal technique, composition and lighting which are sometimes closer to Liotard and the Swiss school than to the French masters who attracted Ramsay. Although he taught pastel drawing in Edinburgh (among his pupils was Jane Welsh Carlyle, whose husband wrote a memoir of the artist), he founded no school and left no lasting influence.

Skirving used the Edinburgh framers William Chalmers & Son (118 High Street); accounts survive for the period 1814–18.

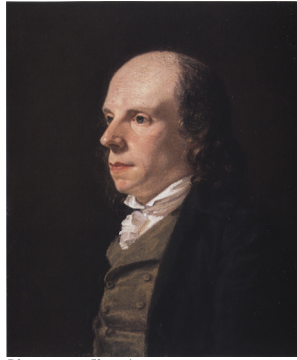

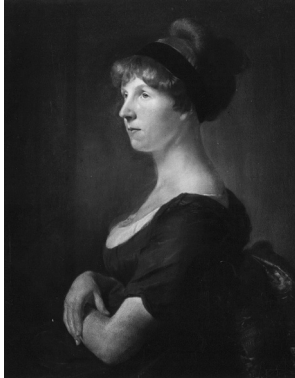

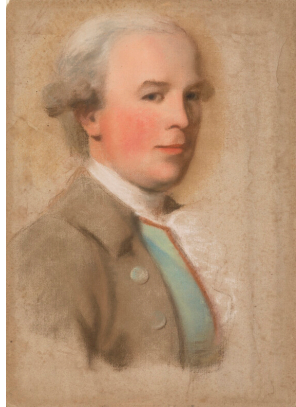
